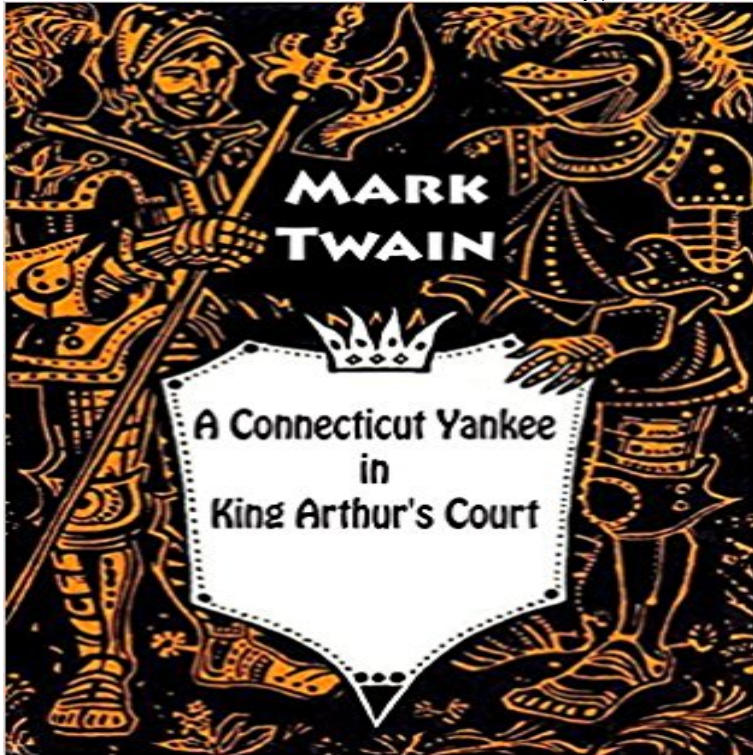


## A Connecticut Yankee in King Arthurs Court (illustrated)
