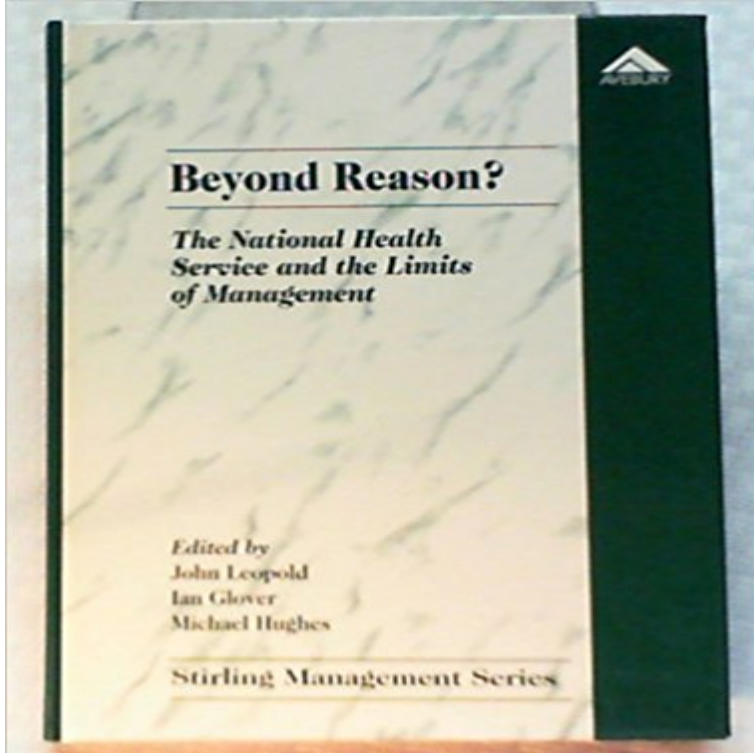


# Beyond Reason?: The National Health Service and the Limits of Management (Stirling School of Management)
