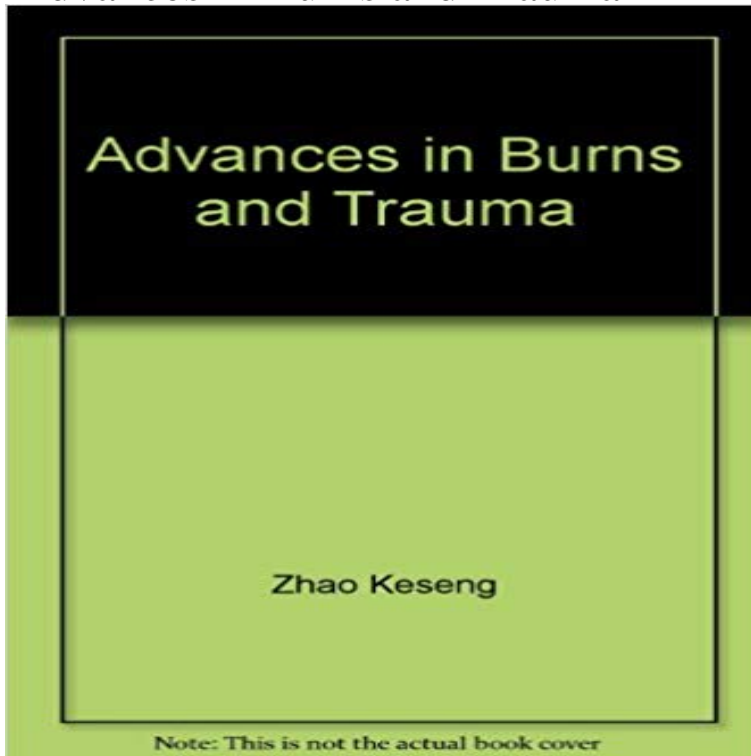


## Advances in Burns and Trauma
