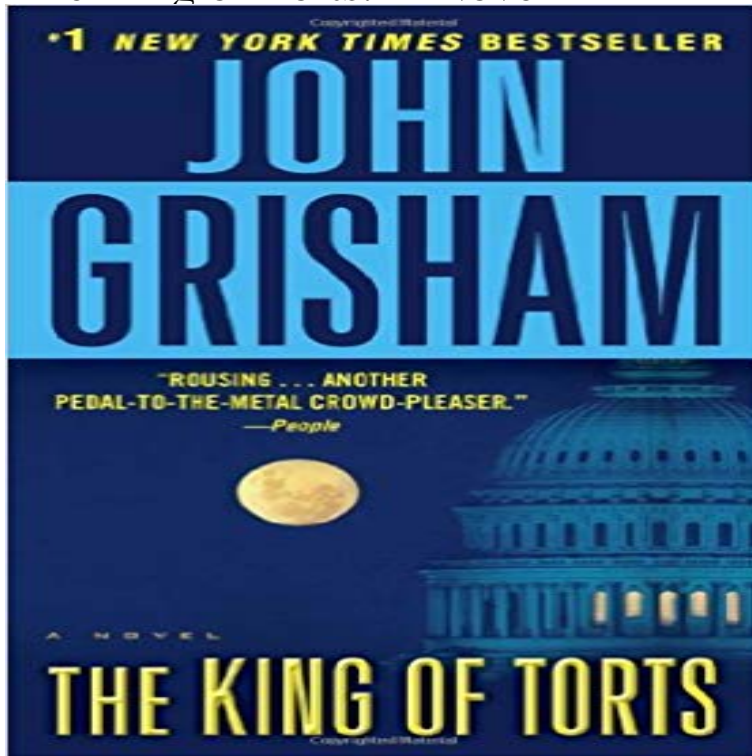


## The King of Torts: A Novel
