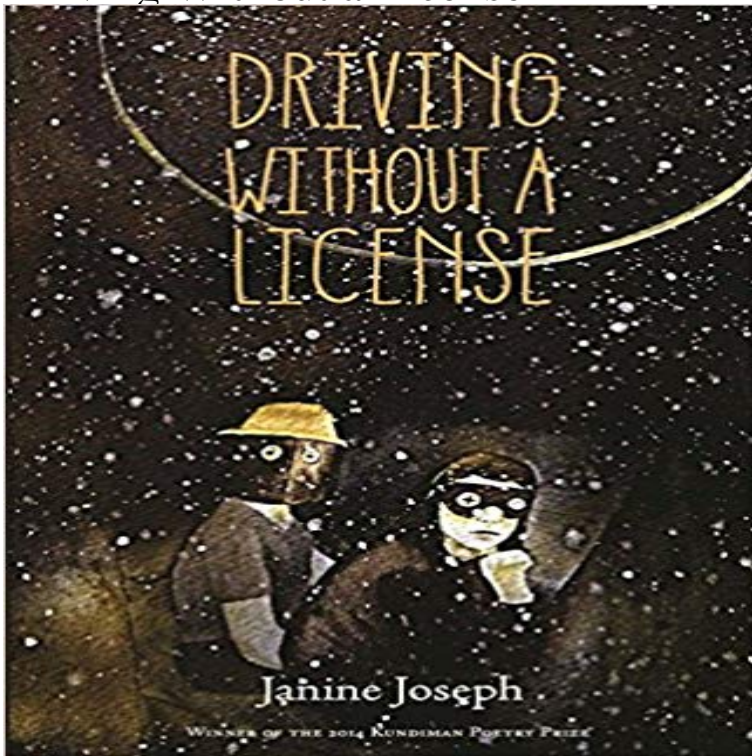


Driving Without a License
