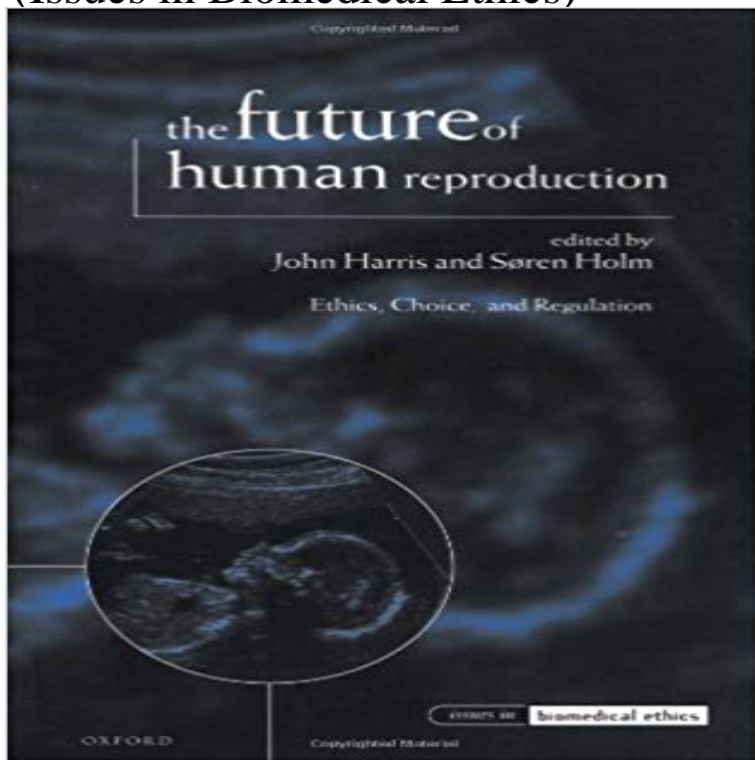


# The Future of Human Reproduction: Ethics, Choice, and Regulation (Issues in Biomedical Ethics)
